

By Train (SEPTA Thorndale Line and Amtrak):

From the Ardmore Station, walk toward Coulter Avenue. Turn right onto Coulter Avenue, then turn left onto Saint James Place. Turn left onto Parking Plaza, which runs through the center of Suburban Square. GKH is located in the Times Building on Parking Plaza. Take the elevator to the 4th floor. The GKH office is located within the Simon Capital suite 402.

By Car:

From the west, via Montgomery Avenue

Heading east on Montgomery Avenue, pass Ardmore Presbyterian Church on the left and make the first right onto Anderson Avenue. Make the first left onto Coulter Avenue. Park in any of the lots designated for Suburban Square shops and businesses. Parking Plaza runs through the center of Suburban Square, parallel to Coulter Avenue. GKH is located in the Times Building on Parking Plaza. Take the elevator to the 4th floor. GKH is located within the Simon Capital suite 402.

From the east, via Montgomery Avenue

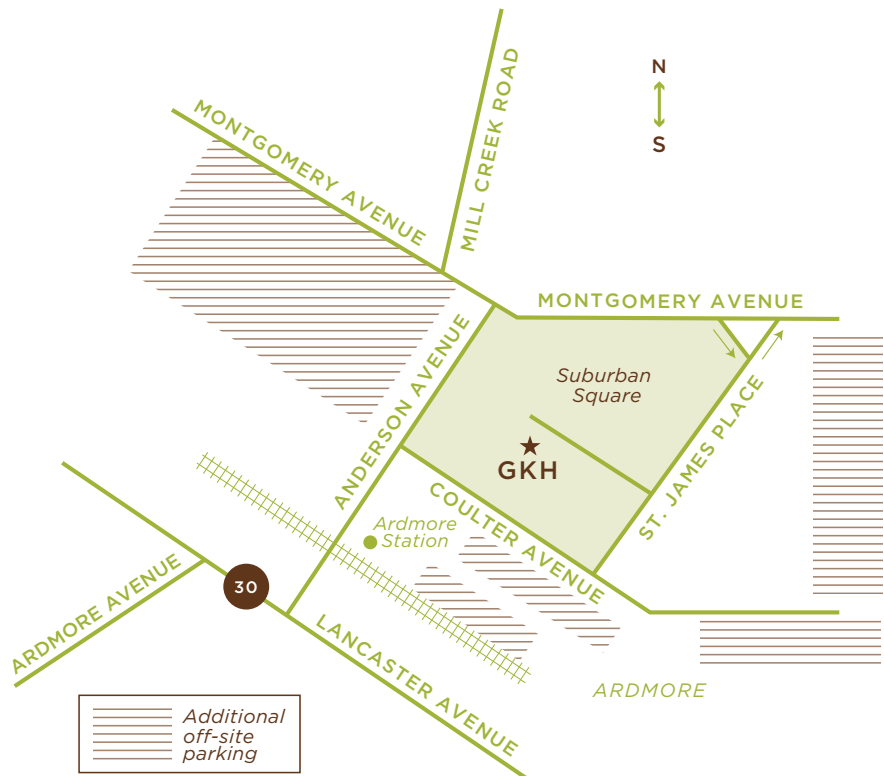
Heading west on Montgomery Avenue, after passing St. Georges Road on the right, make the first left onto Anderson Avenue. Make the first left onto Coulter Avenue. Park in any of the lots designated for Suburban Square shops and businesses. Parking Plaza runs through the center of Suburban Square, parallel to Coulter Avenue. GKH is located in the Times Building on Parking Plaza. Take the elevator to the 4th floor. GKH is located within the Simon Capital suite 402.

From the west, via US 30/Lancaster Avenue

Heading east on US 30/Lancaster Avenue, after crossing Ardmore Avenue, make the first left onto Anderson Avenue. Cross under the rail line and use any lane to turn right onto Coulter Avenue. Suburban Square is in the first block on the left. Park in any of the lots designated for Suburban Square shops and businesses. Parking Plaza runs through the center of Suburban Square, parallel to Coulter Avenue. GKH is located in the Times Building on Parking Plaza. Take the elevator to the 4th floor. GKH is located within the Simon Capital suite 402.

From the east, via US 30/Lancaster Avenue

Heading west on US 30/Lancaster Avenue, after crossing Station Road and Cricket Avenue, make the first right onto Anderson Avenue. Cross under the rail line and use any lane to turn right onto Coulter Avenue. Suburban Square is in the first block on the left. Park in any of the lots designated for Suburban Square shops and businesses. Parking Plaza runs through the center of Suburban Square, parallel to Coulter Avenue. GKH is located in the Times Building on Parking Plaza. Take the elevator to the 4th floor. GKH is located within the Simon Capital suite 402.
